Statutory Declaration on RTI Act 2005

Thakur Institute of Management Studies, Career Development & Research (TIMSCDR), Kandivali (E), Mumbai – 400101 is hereby giving its statutory declaration as per Section 4(1)b of RTI Act 2005.

TIMSCDR is established in the year 2001, managed and governed by the Thakur Educational Trust registered under Mumbai Public Trust Act 1950 with registration number E-12737 (Mumbai) dated 18/04/1990. The Institute is Self-Financing and of the Hindi Linguist Minority category.

TIMSCDR conducts Post Graduate course of “Master in Computer Applications (MCA)” with an intake capacity of 180, affiliated to University of Mumbai and approved by AICTE, Government of Maharashtra, Directorate of Technical Education (DTE) with DTE Code MC3168.

The curriculum and syllabus of the MCA program is prescribed the University of Mumbai covering Computer Applications, Information Technology and Management studies. The examination and award of degrees is done by the university.

The fee for the program is prescribed by the Fee Regulatory Authority (FRA) of the Govt. of Maharashtra.

TIMSCDR has *Vision* to provide education in software application and *Mission* to achieve excellence in teaching and training of the relevant course with emerging technologies with focus on development of leadership quality.

The *Quality Policy* and work pattern of the Institute ensures compliance of norms and standards and guidelines set by the regulatory bodies such as All India Council for Technical Educational (AICTE), University Grant Commission (UGC) and University of Mumbai, Mumbai.

TIMSCDR has a Governing Council setup as per directives of AICTE to manage the affairs of the Institute, including academic, administrative and financial matters. The Governing Council has appointed various Committees with defined functions as per policy decisions and report to the Council.

The Governing Council includes external members from academics, Industry, DTE, AICTE and University of Mumbai.

TIMSCDR has a College Development Committee, including local members from education, research, industry and social service as per the Maharashtra Public University Act 2016, to oversee the function of the Institute.

The faculty and non- teaching staff are appointed as per rules and regulation of the Govt. of Maharashtra, AICTE, UGC and University of Mumbai. The remunerations are paid as per regulation from time to time.

The expenditure for the Institute activities is incurred as per budget allocation approved by the Governing Council. All financial transactions of the Institute are subject to internal and statutory audits by qualified firm of chartered accountants.

TIMSCDR has an Organizational Structure including key personnel with defined roles and responsibilities.

TIMSCDR has prescribed the roles, responsibilities, facilities etc. for Employees and Students in the respective Handbooks for their information and compliance.

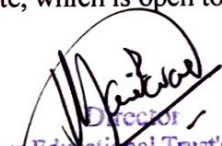
