To block a sender is to click Block in the advanced Sender Settings dialog.




# a. Phishing: Fake UPI link case

Cybercriminals employ a dishonest technique called phishing to try and fool people into disclosing personal information like passwords, usernames, or bank account information. Phishing in the context of UPI typically entails sending emails or messages that impersonate trustworthy sources in an attempt to lure consumers into clicking on harmful links.


In the digital age, with the widespread use of online payment systems like UPI (Unified Payments Interface), cybercriminals have devised cunning methods to exploit unsuspecting individuals. One prevalent tactic is the use of fake UPI links in phishing scams. Understanding and recognizing these scams is crucial to safeguarding your financial information.

#### Fake UPI Link Scenarios:


 Fraudulent Messages: Scammers pretend to be from reputable banks or payment providers and inform you that anything is wrong with your account. A link that purports to take the reader to the solution of the issue is usually included in the message.



2. Prize or Offer Notifications: Rewards, discounts, or special offers are some of the ways that con artists entice victims. Phishing traps are set up where victims are tricked into clicking on a UPI link in order to get the purported prize.



Urgent Payment Requests: Scammers may pose as someone you know and send
messages stating they are in urgent need of money. Frequently, these messages
contain phony UPI links, tricking consumers into thinking they are supporting a
friend or relative.



#### **Protect Yourself from UPI Phishing:**

- 1. Educate Yourself: Be aware of typical phishing techniques and exercise caution when you receive unusual messages or offers.
- 2. Install Security Software: To safeguard your devices from possible dangers, install strong antivirus and anti-malware software. Eg: McAfee, kaspersky



3. **Enable two-factor authentication (2FA)** to further secure your accounts and offer an additional degree of protection to your UPI transactions.



 Report Suspicious Activity: Report any phishing attempts you come across to your bank or the relevant authorities. This promotes awareness-building and the taking of preventative action.

#### o Phishing Real-Life case:

The "Google Docs Phishing Attack" is a well-known and historical illustration of a significant phishing attack that happened in 2017.

Gmail users were the target of a major phishing attempt in May 2017. The attack consisted of sending a phony email requesting the recipient to see a Google Docs document, purporting to be from a known contact. When the link in the email was clicked, a phony Google login page was displayed to the recipient.

#### Scenario:

#### **Deceptive Email:**

An email appeared to be from a familiar person to the users. According to the email, the sender shared a Google Docs document with the recipient.

#### Fake Google Login Page:

Those who clicked on the email's link were taken to a phony Google login page that looked real. Users were asked to input their Google login information (password and email) on the page.

## **Capture of Credentials:**

Users who unintentionally gave the attackers access to their Google account credentials did so by entering their login details on the fraudulent website.


#### **Unauthorized Access:**

With the credentials they had acquired, the attackers were able to access the Gmail accounts of the victims. Once inside, they might have access to contacts, emails, and other private data.

## Spread of the Attack:

There was a self-propagating element to the phishing attack. After an attacker obtained access to a user's account, they would use that information to send more phishing emails to the victim's contacts, thereby continuing the attack.

# b. Reversal of UPI transaction

Reversal of a UPI (Unified Payments Interface) transaction after a fraud incident involves a specific process that varies among banks and payment service providers.

An overview of how to start the reversal procedure following a UPI scam:

#### 1. Contact Your Bank:

Get in touch with your bank's customer service as soon as you become aware of an illicit or fraudulent UPI transaction. Make use of the official means of communication—phone, email, or in-person visits—that your bank has offered.

#### 2. Provide Transaction Details:

Have the specifics of the fraudulent transaction, such as the date, amount, and transaction reference number, readily available. For the bank to look into and start the reversal procedure, this information is essential.

#### 3. Lodge a Complaint:

Send your bank a formal complaint about the fraudulent transaction. Certain banks might have a section solely focused on handling disputes or reporting fraud. To start the investigation, fill out the appropriate forms or supply the information needed.

#### 4. Follow Bank Procedures:

Initiate a reversal and report fraud by following your bank's instructions. Since different banks could have slightly different procedures, it's critical to follow the particular instructions given by your bank.

#### 5. Urgent Blocking of UPI Credentials:

Ask the bank to immediately block your UPI credentials in order to stop any more fraudulent transactions. This can entail adjusting your UPI PIN and implementing extra security precautions.

# 6. Cooperate with the Investigation:

Give your bank's investigation your whole cooperation. This can entail supplying any extra data or supporting materials that are needed during the procedure.

#### 7. Timeline for Reversal:

The reversing process may take a different amount of time. While some banks might handle the situation swiftly, others might take longer. Have patience, but continue to inquire about the investigation's progress on a proactive basis.

#### 8. If required, escalate:

Elevate the issue within the bank if the reversal process takes too long or if you're not happy with the outcome. You can use the grievance redressal process available to most banks.

# 9. File a Police Complaint:


When fraud is severe, you should think about reporting it to the police. Give the relevant information and records to the law enforcement agencies.

# c. National Payments Corporation of India (NPCI): UPI Dispute Redressal Mechanism

Every end-user customer can raise a complaint with respect to a UPI transaction, on the PSP app / TPAP app.If the dispute is not resolved at the bank level, and if both banks involved in the transaction are members of NPCI, the dispute can be escalated to NPCI for further intervention.
